## Fall 2013 Election Trip Report

### IASGP election observation trip to Berlin (September 18-23, 2013)

The IASGP organises a trip to Berlin every time there is a federal election to provide participants with a chance to meet candidates a few days before the elections and opportunities to collect first class research material. With the kind support of the DAAD, we were able to offer a grant to participants to cover part of the costs for accommodation and travel. 46 scholars of German politics from the US, the UK, the Czech Republic, Italy, Belgium, Luxembourg and Germany joined our election observation trip- we are becoming a truly international association! Our participants also ranged from eminent retired professors to PhD students and a third of them were female scholars.

Arrival was on a cold rainy Wednesday before the election. We started at 9 am on Thursday for a meeting with Gert Olav Göhs at the CDU headquarters for a detailed and confident presentation on the CDU campaign strategies, opinion polls and policies. We then dashed to the historic Rosa Luxembourg House for a presentation by election campaign leader Matthias Höhn from Die Linke. Höhn provided us with lots of information on the posters, the different campaign strategies in the East and the West and- it must be mentioned- a rather copious buffet which was much appreciated! Nick Pickard, Political Counsellor and Consul-General for North East Germany welcomed us at the British Embassy to give us a British government perspective on the elections. This was very relevant in light of the British plans for change in the EU. After a quick lunch, we met Prof. Martin Neumann MdB in the now vacant FDP tower of the Bundestag. Prof. Neumann talked extensively about his area of competence, education policy, but also answered questions on varied topics such as taxation and the Eurocrisis (see <http://www.martin-neumann.net/content/martin-neumann-diskutiert-mit-renommierten-parteienforschern-%C3%BCber-den-fdp-bundestagswahlkampf>). We finished the day with the SPD final campaign event at the Alexanderplatz, where Frank Walter Steinmeier, Sigmar Gabriel and Peer Steinbrück put the accent on social justice and called for change.

Friday morning started with a visit to the headquarters of the Greens, where Reinhard Bütikofer MEP gave a candid assessment of the Green's manifesto and election strategy. At the Landesvertretung Hessen, Wolfgang Gibowski had kindly organised a roundtable with Dr. Yvonne Schroth (Vorstandsmitglied Forschungsgruppe Wahlen), Richard Hilmer (Geschäftsführer infratest dimap) and Dr. Viola Neu (Leiterin der Wahlforschung der Konrad-Adenauer-Stiftung), followed by lunch. Our final official meeting was with the honorary

president of the IASGP, Dr. Eva Högl Mdb, who gave us an open briefing of the SPD's manifesto and elaborated on her own campaign in her constituency Berlin Mitte. The day ended with a lovely buffet at the Max und Moritz restaurant in Kreuzberg sponsored by the IASGP. This was a great opportunity for everyone to get to know each other.

On Saturday, we attended the final CDU election campaign event in the Tempodrom, where Angela Merkel delivered a message of confidence and hope and the public was entertained with songs such as "Angie wird noch kurz die Welt retten". Some of our participants went to the final Green election campaign event, and one of our participants managed to get an interview with a member from the AfD on Saturday as well!

On election day, we had some much needed free time until the election parties started. We had managed to get tickets to the SPD, the Greens, the Linke and a select few for the FDP parties. The group spread out and could attend those parties which each preferred. Some did a bit of party hopping and attended two or three! While the atmosphere was reportedly the best at the Linke, the FDP election party died down at 8.30.

Finally, on Monday we attended the election briefing by the Bundespresseamt with Richard Hilmer (Infratest-dimap), Matthias Jung (Forschungsgruppe Wahlen), Prof. Dr. Renate Köcher (Institut für Demoskopie Allensbach) und Dr. Peter Matuschek (forsa). The official IASGP election trip ended with this, but the DAAD had organised a roundtable discussion on the elections later in the day, where Prof. Joyce Mushaben from our group joined the panel. Last but not least, we must officially announce the winner of our election sweepstake: Gianfranco Baldini from the University of Bologna, a first time participant! Second place went, for the second trip running, to Wayne Thompson, although the battle for podium places couldn't have been closer! Wayne actually tied with both Charlie Lees and Meredith Heiser-Duron, but his turnout guess was fractionally better. Thanks must go to Michael Koss, European Secretary, and Dan Hough from the Executive Committee for all their help to Martine Huberty in organising this trip.

### *IASGP Funding Opportunity*

The IASGP offers members of the Association the opportunity to apply for financial support in organising events that directly help to profile the Association's activities. The committee has earmarked a maximum of £2,000 annually for this purpose. The scheme will run for 5 years (until the end of 2013) when it will be reviewed with a view to extension and/or expansion.

Members wishing to take advantage of this scheme should take notice of the following points

- Members should be hosting, or heavily involved in organising, an event that clearly raises the profile of the IASGP.
- Applications should contain details of the event, an explanation of why it is in the IASGP's interest to support it and how the IASGP's contribution will be spent.
- Preference will be given to events that are linked to publications, especially and explicitly those that involve *German Politics*
- A two page event report will be provided within three months of the event's conclusion. This report will be published on the IASGP's website and in the IASGP's newsletter.
- The IASGP, its logo and its website should be advertised in any marketing related to the event, the event's programme and literature produced thereafter.
- This scheme is not intended to support the individual participation of members at conferences.
- Applications will be reviewed and assessed by members of the executive committee. The committee's decision will be final
- Members should send their applications (via email) to the North American and European Secretaries.
- There is no deadline (i.e. members can apply at any point in the year). Applications do, however, need to be received at least two months prior to the proposed event taking place.
